Introduction

Pulmonary disorders are a frequent cause of admission for patients across the lifespan in the acute care setting. In addition, many patients suffer from chronic respiratory disorders. Rapid assessment of the respiratory system and early intervention is vital. This interactive day is designed to review assessment, pathophysiology, laboratory and diagnostic findings, pharmacology, management, and outcome monitoring in these patients. Case studies, including ABGs, will be used throughout the day to promote critical thinking and correlate all material. The conditions covered will include:

- Respiratory assessment
- Respiratory pharmacology
- Pneumonia
- Pulmonary embolism
- Pleural effusion
- Pneumothorax
- Epiglottitis
- Tuberculosis
- Respiratory insufficiency and failure
- Rapid sequence intubation
- Acute respiratory distress syndrome
- Restrictive airway diseases
- Acute and chronic bronchitis
- Emphysema
- Lung cancer

Objectives

1. Verbalize an understanding of the basic and advanced assessment parameters specific to patients with pulmonary disorders.
2. Differentiate between the various pharmacologic agents used in the treatment of pulmonary disorders.
3. Verbalize the ability to interpret arterial blood gases and correlate the findings to various presenting signs and symptoms and pathologic conditions.
4. Relate the pathophysiology of various acute pulmonary disorders to the clinical manifestations, lab and diagnostic abnormalities, medical and nursing management, and outcome assessment.
5. Recognize the pathophysiology and clinical presentation in various chronic respiratory disorders.
